### Terms and Conditions

#### Tuesday Jackpot Poker Tournament

1. The Tuesday Jackpot tournament will run on Tuesdays from 7th May 2024 and is open to all customers.
2. Each entrant must register at the Poker Desk from 6:15pm prior to the commencement of the tournament at 7pm, late registrations must be registered by 9:20pm.
3. All entrants must pay the entrance fee of £40 (£28 buy-in, £5 Jackpot, £5 registration fee and £2 promotional contribution) prior to the commencement of play.
4. Promotional contribution goes to the Cardroom Promotional Fund.
5. Jackpot fee contributes to the progressive jackpot with 20% withheld as a reserve fund for the following week should the jackpot be won.
6. Prior to the commencement of the tournament 25,000 starting stack of chips will be placed on the table for each paid entrant.
7. A starting stack of chips may be placed in a seat to accommodate late entrants (so all antes and blinds have been appropriately paid). An unsold seat will have such a stack removed at a time left to the discretion of the tournament director (usually at the end of the rebuy period).
8. Unlimited re-entries will be permitted for the specified late registration period of the tournament but will be relocated to another table if possible. A re-entry will need to join an existing alternate list and is not seated as a re-buy. They will be seated as close to the big blind as possible if being seated manually, or seated randomly if such a system is in place (i.e., seating cards or a digital seating system). Registration fees will apply.
9. All MG Poker Tournaments are governed by the Tournament Rules displayed in the Poker Room and are available on request.
10. Tournament Director's decision is final.
11. Completed competition guarantees a £1,000 prize pool
12. 10% of the field paid in prizes, to be determined by the Tournament Director.
13. All prize money will be paid out to players in cash as per the pay-out structure available from the Poker Desk.
14. The winner (winners in the event of a deal) will proceed to the Jackpot Selection which will be carried out as follows;
  - a. The jackpot deck will be obtained from Cash Desk and checked by a cardroom supervisor/senior member of staff
  - b. 48 cards will be spread face up in suited order, not including the Ace of Spades
  - c. The Ace of Spades will be added as the 49<sup>th</sup> card
  - d. The jackpot deck will be shuffled by a member of cardroom staff using standard casino shuffles and then spread face down for the winner to select cards under the supervision of a cardroom supervisor/senior member of staff.
  - e. In the event of a deal, players may split the total number of picks under the condition that picks are kept clear and individual for camera purposes
  - f. The total number of picks will be determined by the amount of money in the jackpot (not including reserve)
    - i. Up to £2,499 – 4 Picks
    - ii. £2,500 to £4,999 – 5 Picks
    - iii. £5,000 or more – 6 Picks
  - g. Players will make the total number of picks from the face down shuffled deck. These picks will be isolated from the remaining cards and turned over one at a time by a member of cardroom staff

- h. The Ace of Spades must be revealed within the picks for the Jackpot to be won
  - i. In the event that the Ace of Spades is found, all remaining picks will be revealed, as will the remaining cards from the deck to ensure there is only one Ace of Spades in the Deck and full deck check will be carried out
  - j. Should the Ace of Spades not be revealed in the picks, the full deck will be revealed to prove the Ace of Spades was within the remaining deck, the jackpot will not be won and will roll over to the following week.
15. Entry constitutes acceptance by the entrant of these terms and conditions.
  16. Any complaints or disputes should be brought to the immediate attention of Venue Management for resolution.
  17. The Promoter reserves the right to cancel or amend the promotion at any time. If participants have already met the qualifying criteria for the promotion, they will be entitled to participate in the promotion on the terms entered, (subject to any expiry or other conditions contained in these terms) and entitled to any benefits associated with the promotion.
  18. Employees of the Promoter, their agents, families, or household members are prohibited from participating in this promotion.
